- Application Fees apply – contact Council Development Services Section on (02) 6393 8530 to obtain fees – fees will vary depending on size and number of devices.**
- Public Liability Certificate of Currency of Insurance for not less than \$10 million must be attached to application with “Orange City Council” noted on the policy as an interested party. Insurance must be taken out with an Australian Prudential Regulation Authority (APRA) approved insurer if the activity is to be conducted on Council’s land.**
- WorkCover Certificate (Green Card) must be attached to this application (where applicable).**
- Applications must be received at least five (5) working days before the event.**
